Election of Executive Committee for the year 2023 -2027 Election Bye laws

1. Short Title & Definitions

- 1.1. These Bye-laws shall be called the 'Election Bye-laws' and shall govern the conduct of Election of Executive Committee of INDIA TAEKWONDO (IT).
- 1.2. In these By-laws, unless the context otherwise requires: -
- 'Category of post' means the post reserved for males or female (a)
- 'clause' and 'sub-clause' means the clause and sub- clause of these Bye-laws; (b)
- 'Executive members' means Members of Executive Committee of INDIA TAEKWONDO. (c)
- 'Form' means the Form appended to these Bye-laws: (d)
- 'IT' means INDIA TAEKWONDO (e)
- WT/WT Asia Observer means the person appointed by the World Taekwondo/ World Taekwondo Asia (f) Coordinator for the Election to ensure fair election process as per World Taekwondo/ World Taekwondo Asia.
- 'Post' includes the office of President, Secretary General, Treasurer, Sr. Vice- President, Vice President, (g) and Member of Executive Committee of INDIA TAEKWONDO.
- 'Rule' means Rules and Regulations of INDIA TAEKWONDO. (h)

2. **Executive Committee**

3. Manner of Elections:

- 3.1 Office Bearers and members of the Executive Committee of IT shall be elected by secret ballot.
- 3.2 Election shall be held at the Annual/Special General Committee Meeting (AGM/SGM) in accordance the procedure prescribed hereinafter, amongst the representatives of the affiliated members (THE VOTING MEMBERS OF THE GENERAL ASSEMBLY)

4. **Electoral College**

- **4.1** Electoral College will be formed by two representative of Each Affiliated Member of IT, they will have one vote each in the election of Executive Committee of IT.
- **4.2** Two (One male and one female) athletes or retired athletes having taken part in the WT Competitions.
- **4.3** The voting units will forward to the IT the names of the representatives for the meeting 23 days prior to holding of elections at the AGM/SGM of the IT, entitled to attend the Annual General Meeting. The names of the representatives entitled to vote and the representative as per the rules of IT constitution must be either approved in the AGM/SGM or duly signed by bothPresident and Secretary General of the concerned unit.
- **4.4** Member Units should submit the names of the Authorized representative to IT Office no later than stipulated in 4.3 of this election byelaws and such intimation shall be addressed to the President / Secretary General of IT on letter head of State Taekwondo Association. For unavoidable reasons a Member Unit may change their representatives not later than 10 working days before the date of General Assembly. The change MUST be approved by President and Secretary General both or Executive Committee of State Taekwondo Association.
- **4.5** The President / Secretary General shall also furnish a duly authenticated copy of the list of authorized representatives received from Affiliated Member/Board to the Returning officer as soon as after his appointment by the President of India Taekwondo
- **4.6** The LIST OF Authorized Representatives received BY IT President/Secretary GENERAL will BE MADE public by pasting on the notice board or in any OTHER manner as may be decided by the returning Officer(s), appointed to conduct the election of IT.

5. Returning Officer

As soon as may be before / after the issue of the Notice for the AGM/SGM, the President of IT shall nominate a person as Returning Officer(s) for the conduct of Election of the Executive Committee of IT in accordance with the provisions of these Bye-laws and Constitution of IT.

6. Nomination of Candidates:

- 6.1 The nomination of a candidate for election as Executive Committee shall be made in **Form 2**.
- **6.2** Nominations will be submitted duly signed by any candidate whose name will be there in Electoral College, and should be proposed and seconded by an authorized representative of IT AGM/SGM.
- **6.3** Each Nomination Paper shall be delivered personally to the Returning Officer in person by the candidate himself/herself or by any authorized representative of the candidate.
- **6.4** No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been submitted to returning Officer.
- **6.5** No person shall be eligible to nominate more than one candidate for the same post, eitheras proposer or seconder and if he so does, his/her signature on the nomination papers, deliveredsecond in point of time to the returning Officer shall be deemed to be inoperative.
- 6.6 The returning Officer shall prepare a list of all nominations received by him, post wise, in Form

3; and publish the same in a conspicuous place in his office or display on website of IT

7. Scrutiny of Nominations:

- **7.1** The Returning Officer in his Office shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.
- **7.2** As soon as may be after the scrutiny process of all candidates has been completed by the Returning Officer, he shall prepare a list of validly nominated candidates in **Form 4** and Candidates can take a copy from the Returning Officer.
- **7.3** After the scrutiny of nominations, each candidate shall have 3 days to raise an objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination.

8. Withdrawal of candidatures:

- **8.1** Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature in three days' time.
- **8.2** Notice of withdrawal of candidature shall be submitted in **Form 5**, either by the candidate himself/herself or by the authorized representative of the candidate.
- **8.3** Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- **8.4** The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- **8.5** As soon as may be after withdrawal the Returning Officer shall prepare the final list of contesting candidates in **Form 6**, display a copy of the said list in conspicuous place in his officeor on IT website. And also furnish a copy of the same to each of the candidates/their authorized representatives, if they so demand.
- **8.6** The names of the contesting candidates in **Form 6** shall be arranged, for each post, in alphabetical order according to English alphabets.

9. Uncontested Returns; and Contested Elections

- **9.1** Where the number of contesting candidates for any post or category of post, in **Form 6** isequal to the number of posts to be filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election such post.
- **9.2** Where the number of contesting candidates for any post or category of post in **Form 6** ismore than the number of posts to be filled, a poll shall be taken by secret ballot for those posts remaining unfilled.
- **9.3** The ballot papers for these posts remaining unfilled shall be in **Form 7** to **Form 12** to be made individually for each post.
- 9.4 The names of contesting candidates on the ballot papers shall appear in the same order as in Form6.

10. Poll:

- **10.1** The Poll for the posts remaining unfilled under clause 9.2 above shall be taken post-wise, and shall commence **during the AGM as per the Agenda Item Elections.**
- **10.2** Each contesting candidate can nominate one person, (If he/she so desires), only from amongst the Authorized representatives list of IT AGM/SGM, to be present at the Poll (Polling Station).
- **10.3** At the poll, each authorized representative of affiliated member of IT, whose name is included in the Electoral College list in **Form 1**, shall be entitled to :-
 - (i) Cast one vote for each of the posts remaining unfilled, where only one such seat is tobe filled;
 - (ii) Each voter can cast 1 vote for each contested seat in election.
- **10.4** In case any voter casts his/her vote for more than one candidate, or for more than 2 candidates, as the case may be, then his/her vote for that post shall be invalid.
- 10.5 Each voter shall be required, before he is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College list in Form 1 used by the Returning Officer for taking the poll.
- **10.6** The voter shall record his / her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose at the polling station.
- **10.7** The voter shall record , his / her vote on the ballot paper by placing a tick mark ($\sqrt{}$) against the name of the candidate of his / her choice , and any other mark , like (x) etc. or word , placed on the ballot paper by him / her shall render the ballot paper liable to rejection
- **10.8** The tick mark ($\sqrt{}$) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer ,and a ballot paper marked otherwise by means of any pen , ball point pen , etc. by the voter shall render the ballot paper liable to rejection
- **10.9** The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuousplace in the polling station that it shall be constantly visible to all present in the polling station.
- **10.10** The Returning Officer shall close the poll at the appointed hour; however, all thosevoters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.
- **10.11** After all the voters referred to in sub-clause (9) have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

- **10.12** Polling will be done in below order:
 - (1) President
 - (2) Sr. Vice President
 - (3) Vice-President
 - (4) Secretary General
 - (5) Treasurer
 - (6) Executive Members

11. Counting of Votes:

- **11.1** The Returning Officer and World Taekwondo / World Taekwondo Asia Observer (If Present) shall take up the counting of votes as soon as may be after polling is complete.
- 11.2 Each contesting candidate can nominate one authorized representative (as clarified in S. No. 10 (2) and He/She shall be entitled to be present at the place of votes.
- **11.3** The Returning Officer and WT World Taekwondo Asia Observer (If Present) shall take up the counting of votes, post-wise.
- **11.4** Each ballot paper on which a vote has been recorded in accordance with sub- clauses (3) to (8) of clause (10) shall be treated as one vote for the candidate for whom ithas been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions of sub-clauses (3) to (8) of clause (10) shall be rejected by the Returning Officer.
- **11.5** The votes validly cast for each of the contesting candidates shall be counted post-wise, and recorded in the descending order of the votes so cast for each candidate in **Form 13**.
- **11.6** The Returning Officer shall thereafter ascertain the result of counting and, the candidates who have secured the maximum no. of votes in the said descending order, post-wise equal to the no. of seats to be filled for each post shall be deemed to have beenduly elected to those posts.

12. Declaration of Results:

The names of contesting candidates who shall be deemed to have been elected at the election in accordance with sub-clause (6) of clause (11) shall be declared as having been dy elected to their respective posts, by the Returning Officer at the Annual General Meeting (AGM) in the **Form 14**.
